Liane,

What follows is an update on the figures that appear about noncommunity water supplies in the third paragraph of the April 21, 2004 letter to Benjamin Grumbles, USEPA from Steven Chester, MDEQ:

In the years since 2004, the number of nontransient noncommunity systems in Michigan has fallen from 1,750 to 1,309. Routine and follow-up lead-copper samples collected at these systems during a recent five year period, 2010-2014, showed 2.2 percent of the samples exceeded the action level for lead (15 ppb), virtually the same percentage as for samples collected between 1999 and 2003 (2.4 percent). Also, 94 percent of these samples showed results equal to or below half the action level of 7.5 ppb, the same percentage determined in 2004. Ninetieth percentile calculations exceeded 15 ppb for 41 nontransient systems between 2010 and 2014. Of these **ten** systems needed to install treatment to optimize their corrosion control.
