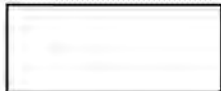
Local, state and federal leaders will host a press conference to announce a comprehensive action plan for addressing drinking water concerns in Flint. Participants will include:

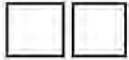
