Dear Representative Muxlow,

I am responding on behalf of the DEQ to your inquiry regarding the Karegnondi Water Authority pipeline.

Currently only the first phase of the KWA water system has been bid and contracted. This portion includes the water intake facilities and shore well. This contract was awarded to L. D'Agostini & Sons, Inc., based out of Macomb, MI.

Several additional contracts are currently in the design phase and have not been submitted for permitting or put out to bid. This includes low service pumping facilities, intermediate pumping and storage facilities, and the raw water transmission pipeline from the lakeshore into Genesee County, which are all part of the KWA system. The pipeline itself is to be constructed through multiple contracts, which will build individual segments simultaneously.

Also, please note that while the DEQ Office of Drinking Water and Municipal Assistance reviews the engineering plans and specifications and issues permits for water system construction projects, the DEQ is not normally involved directly with project contractors or the contracting process, but instead works directly with the water system and its consulting engineers.
