Jennifer,

I attached some files that might be useful.

Drinking Water Sampling....: The Quality Assurance Project Plan that was worked out between Calhoun Co. and EPA Office of Ground Water and Drinking Water, before I was hired. The sampling protocol is in section 10.2. The EPA 3Ts manual is included as an appendix.

Generic QAPP FINAL....: I think this was used as a point of departure in devising the Calhoun County QAPP. It appears to have originated from EPA Region 2. It describes an alternate sampling protocol.

Good to Grow SOP....: This is an adaptation of the SOP that Calhoun developed during the course of the program. The intended audience is other local health departments that want to do something similar to our project.

Good to Grow forms: These are adapted from the forms that Calhoun used, also intended to be shared with other local health departments.
