Dan,

The "Flint Group" made a presentation to the ICC Rural Dev subcommittee awhile back. I did send a letter supporting the project with the understanding that it had Detroit support which we were assured of (they were going to purchase the Imlay City to Flint line from Detroit) at the time. If feasible it will solve drinking water problems in Sanilac county as well as supply untreated water for ag processing. Jim Goodheart from DEQ was at the presentation. We have not taken an official position on the position as an ICC on the effort to the best of my knowledge. As you may be aware some of the Ag organizations have an interest in the project.
