Richard and Liane,

FYI.

Mike, Adam, and I had a conference call with Flint this morning to go over some MOR and monitoring details.

We have received bacti and distribution CI data, but only have some preliminary MOR data. Remaining MOR data will be provided as required by the end of the month.

They appear from what we discussed to be conducting the required monitoring and preliminary data suggest everything is meeting standards. Unit 37 samples will be collected next week, but as previously indicated we do have results from test runs that demonstrate everything was meeting standards.

The WTP has not been Fluoridating at this time, as we suggested they focus on required treatment until things settle down. They indicated they should be ready by June 1 to start Fluoridation. They do have around 0.15 ppm in the raw water.

I suspect there may have been excessive runoff and storm water discharges with the weather we have been experiencing, but you will have to ask the Water Resources Division for details. If a release or overflow is unusual or not expected, both we and the systems should get contacted through the PEAS contact lists.

We expect surface water treatment plants to be capable of treating their source adequately from a microbial standpoint regardless of deteriorating source water quality.

One answer to his question is that any time a system is unable to meet drinking water standards or suspects there may be a water quality problem as a result of an unexpected event (spill, pressure loss, etc.), they are required to notify the consumers and provide appropriate precautionary advice. So no news should be considered good news.

Hi, Mindy. Thank you for listening to him. Mike Prysby, the DEQ district engineer who oversees Flint water treatment and distribution, doesn't have Flint's Monthly Operating Report yet, but he has results from Phase 2/5 and other required contaminant analyses (required to meet so the plant could be put on-line), and health standards are being met, he said. I will ask Mike to send me copies of their Phase 2/5 results and the MOR, and his analysis. I didn't specifically ask about any

contaminant releases, but DEQ has historically been consistently reliable in reporting to us any contaminant releases—but I will ask Mike that also. Richard Benzie is out of the office til Friday or Monday, but I will be in Lansing auditing set-asides next Monday, so I will touch base with him also.

Pat Cook is the DEQ drinking water treatment expert, who Lathan Jefferson talked to at MI DEQ this week. Pat Cook was out of the office at training so I was unable to find out what he told Mr. Jefferson. Mr. Jefferson refused to take Mike Prysby's phone number, which is why he didn't mention Mike's name to you.

Mindy—A Mr. Lathan Jefferson has talked with Tinka, and also with me just now about his drinking water quality. Flint has just switched from Detroit water (from Lake Huron) to Flint River water within the past couple of weeks. Flint River quality is not great, but there is a surface water treatment plant producing water that is currently meeting SDWA standards, according to the MI DEQ district engineer, Mike Prysby. The water has more hardness, and pH and alkalinity may be different from Detroit water. Mike will have more information on the difference in water quality when he receives Flint's first monthly operation report this week. Mr. Jefferson said he and many people have rashes from the new water. He said his doctor says the rash is from the new drinking water, and I told him to have his doctor document this and he can bring to the attention of the MI DEQ, since lab analyses to date show that the drinking water is meeting all health-based standards. He has no interest in speaking with Mike Prysby; he doesn't trust anyone in MI government. He asked me for free drinking water lab analyses, which I was unable to provide. He only wants to speak with someone from EPA Headquarters.
