I am not familiar enough with the details of the water withdrawal legislation to know if that potential impact is even a consideration in our determinations. I find it hard to believe it would not be a consideration since the impact of the Flint withdrawal could increase the impact of the downstream discharges on fish populations (not to mention the benthic community), unless WRD were to restrict the discharge based on lower flows in the receiving stream.

Brant should know if it is a consideration in water withdrawal, but I think it would be helpful to have Chuck present for any discussion that involves NPDES permits.
