The issue may be moot by October as the County likely needs to bond prior to then. Dave indicated another community had bonded with a rate around 5.2% and if the county could get something similar they will probably move forward. Dave indicated that he previously had discussions about DWRF funding with Jeff Wright, indicating to him that it is not a viable option, particularly given the time constraints for construction.
