On **Monday, March 12, 2012 from 9:00 am to 10:00 am** the Flint River Corridor Alliance (FRCA) will be hosting Jeff Wright, Genesee County Drain Commissioner and CEO of the Karegnodi Water Authority, for a special presentation on the Karegnodi Water Authority. The presentation will occur in the UM-Flint Innovation Incubator, Rm. 207 on the 2nd floor of the Northbank Center, 432 N. Saginaw, Flint, MI 48502.

The purpose of the meeting is for FRCA partner organizations to have an opportunity to learn more about the Karegnodi Water Authority and the impacts that it may have on their organizations, the City of Flint and surrounding region. Specific to the Flint River Corridor Alliance efforts, decisions regarding the Karegnodi Water Authority will directly impact redevelopment efforts in and along the Flint River as it relates to the Flint water plant, Hamilton and Fabre Dams, and more.

Detailed Location & Parking Information:

We will be meeting on the 2nd floor of the Northbank Center located at 432 N. Saginaw St., Flint, MI 48502 in Room 207 – the University Outreach Innovation Incubator [IN]. Upon entering the building, take the elevators or stairs up to the 2nd floor. The Innovation Incubator, Room 207, will be located just a few doors up the hall on your left.

In the morning, there is often free on-street parking available on Saginaw St. in front of the Northbank Center and on the block north of the Northbank Center between 2nd Ave. and University (3rd) Ave. The two hour parking limit that appears on the signs along the road is not currently being enforced by the DDA on this stretch of Saginaw St.

If you prefer, you may also park in the parking garage attached to the Northbank Center, the entrance to which is located off of 2nd Ave, just east of Saginaw St. There is a cost of \$2 which must be paid with either \$1 bills or quarters if you would prefer to park in the parking garage. The second level of the parking garage has a skywalk that will bring you into the 2nd floor of the Northbank Center.
