Hi everybody,

Well it's Thursday and I have nothing from GCHD so it looks like DEQ will be doing the sampling this weekend.

We are going to do two schools this weekend (Brownell STEM Academy and Eisenhower Elementary). I think we should continue to have a DEQ staff person accompany DLARA staff during the evaluation and it would be very helpful to have DLARA staff present for the sampling.

I believe that we should have two teams of three for the sampling consisting of two DEQ staff and one DLARA staff. The DLARA staff person can act as the timer and answer questions. We should have one team per school and sample the schools simultaneously.

If Tony Sitko can arrange it, I would like to go back and do the 3 sets of 10 sequential samples at Freeman elementary. I will not be part of the sampling teams at Brownell or Eisenhower but I can go back and get the sequential samples and go back and forth to see how things are going.

Saturday is Halloween so if anyone has plans and cannot attend please let me know so that we can find replacements. **I want to stress that this is voluntary duty and I do not want to guilt anyone into this.** If we cannot get two full teams together we may have to limit the sampling to just one school so we need to get a head count ASAP.
