Hi Sue -

I just wanted to share this although you may have already seen it.

My understanding is that there is now data that shows two to three-fold increases in elevated blood levels in children under 5 years when comparing the pre- and post-switch from Detroit Water system. And that is for 12- and 24-month olds. The impact could be even more devastating on babies especially if they are formula fed and tap water is used to mix it.

Is DEQ the lead on this for the administration? because I fear the fallout is a public health crisis.
