Very nice summary. The heading for *WIC Children* needs to be bumped to the next line and I agree with Eden that we should put water issues to the top of the list under *Reducing and Removing Lead Exposure*. Could we also revise the 3rd sentence in that bullet to read:

"The lead in household water usually comes from the service line that connects your house to the water main or the plumbing in your house, not from the local water supply."

Lead service lines are the biggest lead contributor and are owned in part by the water supply, so it's incorrect to lay all the blame on household plumbing.

Attached is the blood lead testing report with the edits Eden and I discussed in pdf and InDesign formats.

Please keep in mind that the purpose of the report is to inform residents and other interested parties about blood testing efforts in Flint. It is not intended to be a technical report. Recent discussions with GCHD suggest that some of the materials currently posted at www.michigan.gov/flintwater are written at a level that is not accessible by city of Flint residents and I'm concerned that this report has already become far too busy for many people to take in the information.

A technical description of the background and data analysis methods is on the to-do list, but will require additional time to complete. I expect it will include a detailed description of the analysis comparing BLL before and after the switch, as well as the results of our current efforts and all the methods used.
