Hi Sandy,

If the Local EOC is requesting state resources including staff, that request must go through the proper chain of command. Mr. DeVriendt should contact his MSP Emergency Management District Coordinator, LT BJ Roach and request assistance. Assignments of state assets to the LEOC would come down from the State Emergency Operations Center (if appropriate to the incident). If the request is for state human services or health staff then the assignment decision must be made by DHHS leadership. I agree that the best DHHS representative at the LEOC would be someone

that is currently participating in Flint. Dr. Wells would not be appropriate but Linda Dykema is intimately involved. She may be attending the 1:00 meeting already.

The County Commissioners of Genesee County have signed a state of emergency at the county level.

This declaration starts the 72 hour deadline clock to submit a preliminary human health damage assessment to the state.

My presence has been requested at the Genesee County emergency operations center (EOC) at 1 p.m. today.

Because my staff are eligibility staff and are not part of the public health discussions related to this emergency, I am afraid I do not have information that will be helpful to the EOC in determining the amount of human health damage.

Chris DeVriendt, Genesee County acting Emergency Manager, again, has requested assistance from Dr. Eden Wells.

I am requesting guidance on how this should be handled by the local DHHS office, or if someone from Lansing would be a better representative at the EOC.

I have received a message from Chris DeVriendt, Genesee County acting Emergency Manager, that there is a 98% chance that Genesee County will be declaring a State of Emergency. He indicates that with this declaration, we have 72 hours to perform a damage assessment (ie. Human life damage assessment).

He also indicates that he would like to have Dr. Eden Wells on his team.

I think you can share that we are still distributing filters, pitchers, and replacements at four sites during normal business hours. When requested, GCCARD/DHHS has provided filter distributions after hours or at town hall meetings.

The number of requests have slowed down to around 800 to 900 per month. (Average per day = 35 requests)
