I found a typo on the Flint & Your Body flyer. If you haven't already shared, please hold up! I'll get you a fixed version ASAP!

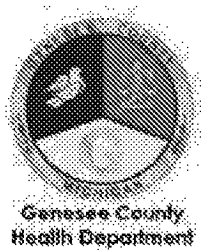
