Roberto,

Flint residents deserve access to clean, safe water, and Gov. Snyder remains committed to working with Mayor Weaver to protect the health of Flint's children and the entire community, both immediately and into the future.

The state already has provided about \$10 million in assistance, and the governor's action plan included increased testing in schools and of blood lead levels, distributing filters and other assistance. Recently, at the Governor's direction, leaders from the Michigan State Police Emergency Management and Homeland Security Division met with the mayor and Genesee County Commission chairman to help them determine the best possible pathway to additional state and federal resources.

We also are inviting every external scientist who has worked on this issue to be our partners in helping improve Flint water so we can arrive at accurate and mutually supported conclusions. We're committed to working together to protect Flint residents.

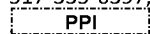
These are initial steps. The governor is meeting soon with Mayor Weaver to discuss other ways the state can offer assistance, and we expect to take further action once the independent Flint Water Task Force makes recommendations.

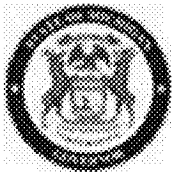

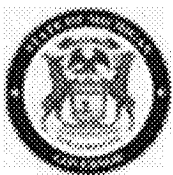
