1. Data from Annual Reports on Public Water System Violations:
 - a. Section 1414(c)(3) of the SDWA requires states to provide the U.S. EPA with an annual report of violations of the primary drinking water standards. I am requesting disaggregated data (city level) from the *Annual Reports on Public Water System Violations* for Grand Blanc Township and Genesee, Wayne, Oakland, Livingston, Macomb and Kent counties. Years 2005-current (2015 or 2014).
2. Consumer Confidence Reports for the City of Flint, Michigan 2010-2013; 2015
3. Copy of drinking water complaints made by citizens and business owners in Flint, Michigan between 2010-current (September 24, 2015).
4. Copy of inspection reports of all water treatment facilities in Genesee County between 2008-2015. Memos from the US Environmental Protection Agency (EPA) regarding water quality concerns in Flint, Michigan, 2013-present

If you determine that some of the requested information is exempt from disclosure, please detail what is being withheld and cite the exemption under FOIA.
