I was not involved in the decision on how much supplemental phosphate should be added when the city returned to DWSD water.

My only other comment has to do with the first statement under the question, "Why is phosphate being added to our water?" The answer begins with, "Homes built before 1986 are more likely to have lead service lines and pipes." It is my understanding that lead piping for service lines or household plumbing has not been used in Michigan since World War II.

The reference to 1986 likely comes from the fact that 1986 was the year EPA banned the use of solder containing 50% lead, and at the same time, formally defined lead free brass as being less than 8% lead. This change was incorporated into Michigan's State Plumbing Code in 1988, so in this state, June of 1988 is often cited as the point at which high lead content solder and plumbing components were prohibited from being used.

It would be more accurate to remove the reference to lead service lines and pipes in that sentence, or at least separate them from the 1986 reference, and use an older time reference for indicating which homes may still have lead service lines or lead piping.
