I am sending this out in Mike Prysby's absence. I believe he may have mentioned it to you previously.

The City of Flint community water system has been selected by EPA to participate in the 2015 Drinking Water Needs Survey. This survey documents the 20 year needs regarding all aspects of the City's public water supply system, including source, treatment, storage, distribution, customer metering, etc. The results of the Needs Survey are used to determine state allocation of federal revolving loan funds.
