It's an interesting question, but I can't really think of a way to offer apples-to-apples for the answer. Boil water advisories happen around the state every month for a variety of causes. There are actually a lot more of them than one might think, but they're meant to be seen as proof the monitoring system is effective and erring on the side of caution in protecting local drinking water.

Remember a boil advisory doesn't mean that the water is automatically dangerous to consume -- in those cases, the operator issues a 'do not use' order. Boil advisories mean a system has elevated one of many potential risk factors (most common being E. Coli) beyond set (conservative) standards, so there's a higher-than-normal risk level.

Remember that this world is about statistical probability and risk management. The testing and monitoring protocols are designed to offer an exceptionally high degree of confidence in water supplies. The water testing thresholds are designed to alert operators very early about the need to make systematic adjustments.

Regular testing of municipal drinking water systems is done to keep a careful eye on drinking water supplies. Flint's latest advisory only affected a portion of its distribution system. This was Flint's second advisory since switching their system in May. That's two more than some communities, of course, but I'm not sure how much hay one could make out of it just yet.

Does it mean you're guaranteed to get sick if you drink water while it's under a boil advisory? No. It means the normal risk from municipal drinking water is infinitesimally minute, and something was detected in the monitoring that elevated that risk.
