Not particularly.

The piece I need to stress is that this isn't a system issue or a water source issue. It's a home plumbing issue. It's why there's so much debate about whose numbers are right or what the real levels are. My house and your house could have totally different plumbing but be right next to each other. Folks expect we know everything. We don't know everything. We know there's no lead in the source water, we know there's none in the water leaving the plant, and we know the system is built of cast iron pipes, so when people ask if the water's safe, the best we can get toward an answer is "it's meeting standards in the system, but some homes have lead plumbing or service lines, so . . ." And that's not been a great message.

State officials admit that monitoring lead in water supplies can be challenging, because the source of the lead is not the water supply, the treatment plant or the distribution system, but the home plumbing and service lines in older homes. Testing requires homeowners to participate in the testing by filling supplied bottles with water samples from specific

taps at specific times of day, individual homes often have very different results for lead tests.
