Joe,

In our discussions about school plumbing assessments we touched on the need code each tap so that when water sampling is done the sample codes match up with the tap coding provided in the plumbing assessment. The link below provides EPA's example coding scheme for water outlets. This example may not be applicable in all cases given that some schools are likely to have multiple levels and others will have sinks in each room, but hopefully it gives you some indication of what is needed for tap coding as part of the plumbing assessment. Example Coding Scheme for Water Outlets

A drinking water bubbler (DW) on the 2nd floor (02) of the middle school (MID), the 15th outlet counted, might be coded as follows.

- MID- 02- DW-015
- DW= drinking water bubbler
- WC = water cooler (chiller unit)
