Action Step No. 2

E-mail sent to DLARA with draft sampling ID protocol.

E-mail drafted with request for schools to prepare documents/information ahead of DLARA visit and on-site assessment. Waiting for comments.

Action Step 4

MDARD incorporated input from MDEQ for the guidance document to restaurants. The final version is being reviewed for inclusion on the website.

Action Step No. 6.

Pipeline flushed and first round of samples for bacteriological analysis collected yesterday (4am at mid-point, 7:30am at CS #3 – Flint WTP) were Non-Detect for total coliform.

The second round of samples were collected yesterday evening at mid-point (Genesee County) and late last night at CS #3 (Flint). Results will be available later this evening and read first thing tomorrow morning. If the second set is all clear, the pipeline will be ready to be placed into service (from a technical standpoint). The pipeline; however, will not be placed into service until Flint, Genesee County, and Detroit agree on and establish a service contract.

The Dort Reservoir will not be placed into service (this facility can be by-passed) until the city determines what to do with the 6 Mgal of water (chlorinated at approx. 100 ppm). What they thought was a connection to the sanitary sewer was discovered yesterday to be a connection to the storm sewer.

Action Step 8

The first weekly meeting with the City of Flint has been scheduled for October 16, 2015. Attendees will include: George Kriszlian (MDEQ) Natasha Henderson (City of Flint), Shelly Edgerton (DLARA), Linda Dykema (DHHS), Dr. Eden Wells (DHHS)

Action Step 9

A tour the Flint Water Treatment Plant has been requested and tentatively scheduled for October 16, 2015. We are waiting for confirmation from City of Flint Officials. Due to potential Scheduling Conflicts this may be re-scheduled for the week of October 19th.

Action Step 13

The initial draft of the sampling protocol has been submitted to EPA and comments have been received.

Action Step 18

Potential bottlenecks have been identified regarding load restrictions. Further discussions with the road commission will be necessary to identify potential accommodations.

Additional Actions.

Outreach was made to the (GCHD) Genesee County Health Department to ask for assistance with the sampling of the Flint Schools. The GCHD has expressed some reservations and further communication will take place to strengthen the partnership.
