This is a little odd since the Genesee County Drain Commissioner is the head of KWA. I am not currently aware of plans to shut down the DWSD pipeline, though no CWS use is anticipated West of Lapeer.

KWA (Genesee County) has Water Withdrawal Permit 2009-001 through WRD and the water withdrawal program for 85 MGD.

The current plan for Genesee County's WTP is to start at 30 MGD and expand to 45 MGD. Flint has a WTP capacity of 36 MGD, though Flint has only purchased 18 MGD Annual Avg Day Demand in KWA. Lapeer has an option to connect into KWA with a capacity of 4 MGD. So much of the 85 MGD is already allocated.

The raw water Lake Huron Pump station and Intermediate booster station have a firm pumping capacity of 60 MGD with space for future pumps.

WRD would need to deal with the permit any permit limitations in regards to its decision process.
