Dear Tamara, Dawn and Mark- I have drafted an Ad Hoc data request for an Excel file that your agency can use to map current Pregnant woman and all past and current enrollees age 0-60 months for identification of high risk lead exposure.

WIC does not allow client listings to be shared outside of authorized WIC Programs, so this data must be mapped by GCHD. MDHHS/WIC does not currently have access to mapping software, but we can assist in sorting data if just specific zip codes would be more helpful.

I will submit the request or modify as needed if you get back to me by tomorrow. This request must then be approved by a WIC supervisor, but I have discussed with the staff who work with the data on the need for quick turn-around.

Hi Terri,

I know that Dawn Scharer has been in touch about the concerns of lead in the City of Flint's water, and the concern for the health of our clients. I met with some community partners yesterday (reps from the city, hospitals, United Way, Red Cross, etc). The United Way is saying that they have funds to provide filters for some of our clients, and can temporarily distribute water, as well. One of the asks of our health department was to provide addresses of WIC clients, so that Hurley can overlay this info on their maps that are showing high lead tests, along with the city's maps of the lead lines, to determine who is at highest need for filters.

My question is, is there any information that we can provide without breaching our client's privacy?
