Dear Citizen Advisory Committee,

It has been some time since our last **citizen** advisory team meeting and we wanted to reach out at this time to those of you who were part of this committee and provide you direct information.

It was encouraging for us to successfully install the recommended Granulated Activated Carbon which led to the City being compliant with the Safe Drinking Water Act but we are now facing questions surrounding the amount of lead that is leaching into drinking water through plumbing and service lines in certain homes. A significant aspect of lead in drinking water is the public education that gives everyone a clear and proper understanding of how this occurs and what are the avenues to reduce the risk.

As we consider when it may be beneficial to reconvene another community meeting, we want to extend to everyone the opportunity to provide input, and to be aware of the latest information.
