- **Percent of children with confirmed elevated BLLs:** The number of children less than 72 months of age with a confirmed elevated blood lead level ≥ 5 $\mu\text{g/dL}$ divided by the number of children less than 72 months of age tested for blood lead, multiplied by 100. Also referenced as "Case Rate."

That could be a valuable reporting number. Give some perspective to the scope of the issue....
