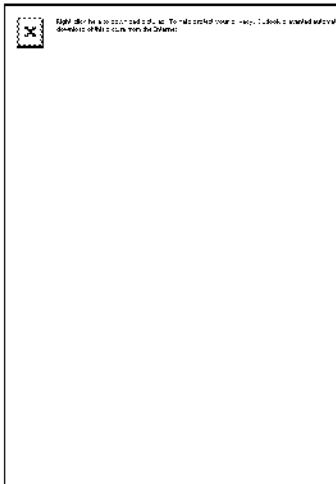




Contaminant Testing Procedures - NSF International

NSF info at this page indicates that filters certified for copper reduction can take a 3 ppm or 3000 ppb level down to 1300 ppb. Not good enough for people with Wilson Disease who need copper <100. None of the filters certified to remove copper that I can see are also certified to remove lead.

I asked Jim Henry of my environmental health staff to research the copper filter reduction issue and talk to the people at NSF. His findings are below. I had a friend who used to work at NSF but is long retired. I remembered from a conversation that often manufactures get products certified for particular chemicals and there is a cost increase with each particular additional certification. So they limit the testing based upon what makes economic sense for them. In this example, it does not mean that the filters we are distributing do not reduce copper but more likely that they did not pay for that certification test to be run. If that test was not run they cannot claim to be "certified by NSF". Oddly Brita does advertise that their filter reduces copper but it is not listed on the sheet in the box as certified by NSF for that

NSF did supply the filters list certified for copper reduction, which is included below for your information.
