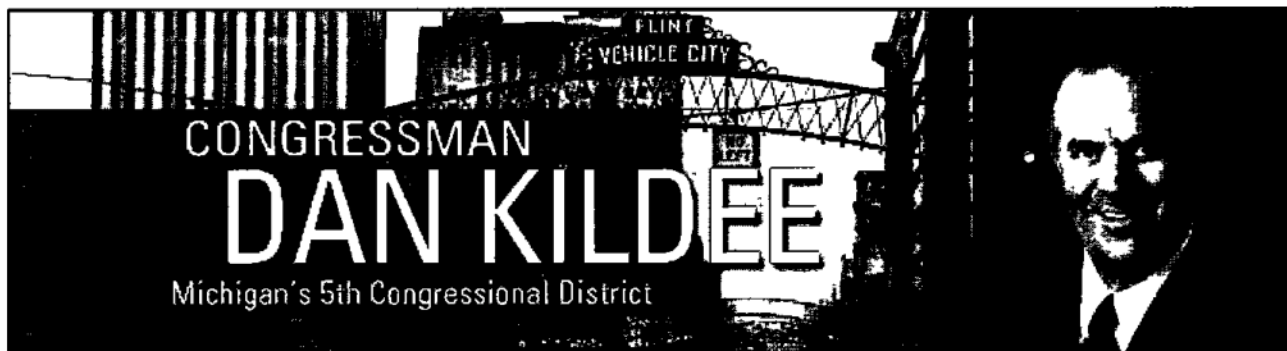

The Flint water crisis is a failure of government at every level, and I am committed to increasing transparency and finding answers to ensure that these failures never happen again. That's why I have [called for an investigation into the causes of water problems in Flint](#).

Simply put, high lead levels in Flint's drinking water are unacceptable, and there must be accountability.

As part of my ongoing efforts, I am holding a **telephone town hall with constituents on Wednesday, October 28th, at 7 p.m. ET** to provide an update on my efforts. I'll be joined by both Dr. Mona Hanna-Attisha and Dr. Marc Edwards, who both conducted critical tests that exposed unacceptable lead levels in Flint.
